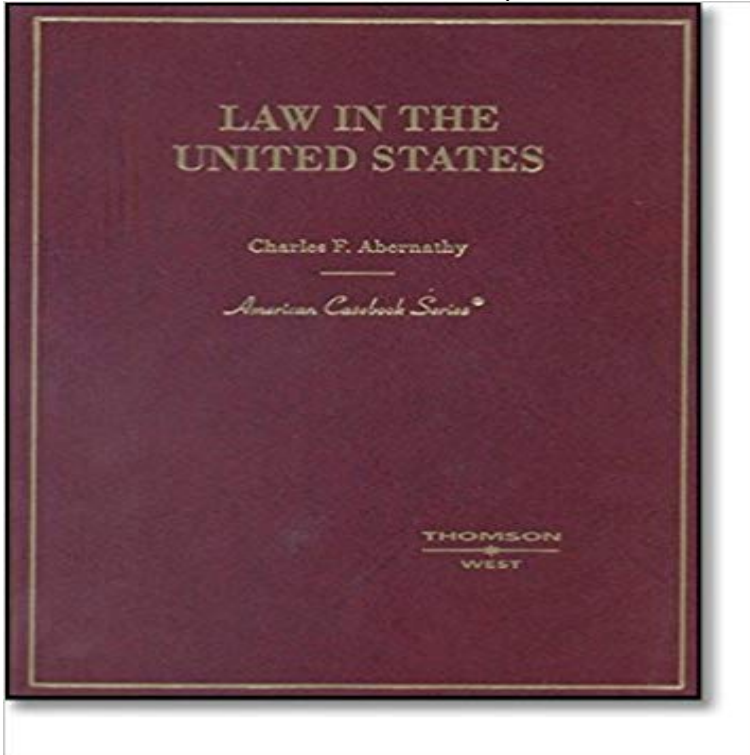


Law in the United States (American Casebook Series)
