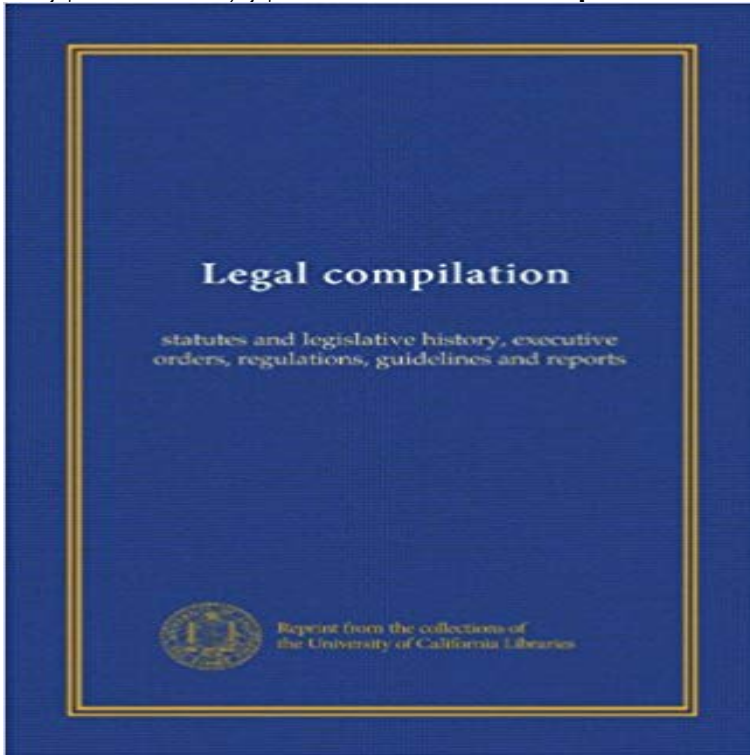


Legal compilation: statutes and legislative history, executive orders, regulations, guidelines and reports
