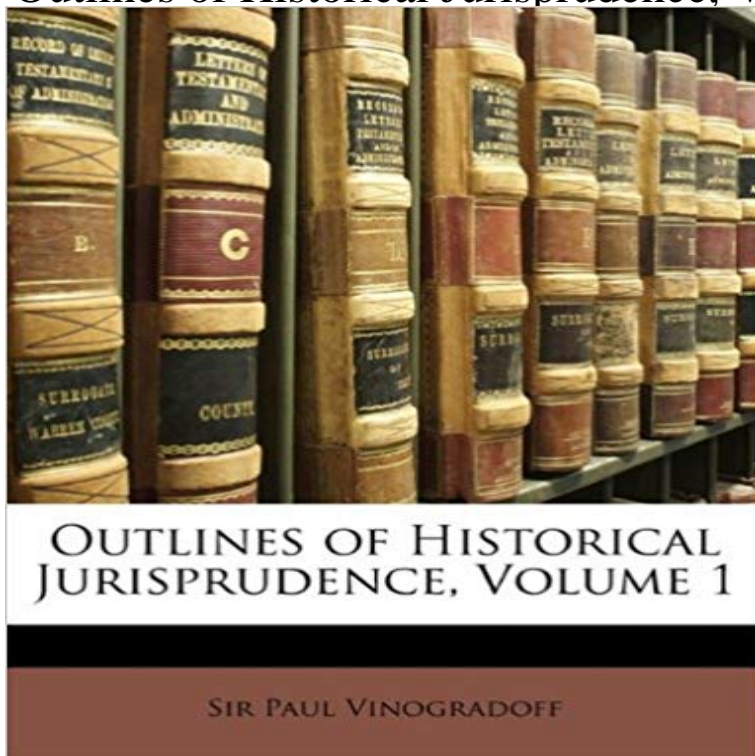


Outlines of Historical Jurisprudence, Volume 1
